CHEPA Research

The significant gender pay gap in Canadian medicine, and the need to boost the number of personal support workers (PSWs) to care for the increasing numbers of elderly Canadians are highlighted in two recent studies of healthcare human resources:

Women doctors in Canada earn less than their male counterparts at all points of the earnings distribution, confirms research by **Boris Kralj** with Danielle O'Toole and CHEPA colleagues **Meredith Vanstone** and **Arthur Sweetman**.

Kralj and Sweetman also published research on the need for increases in the labour force supply of PSWs to deal with Canada's rapidly-aging population and fallout from the pandemic. The publication also addressed accompanying issues such as the number of care hours that should be provided.

Grants

Meredith Vanstone is co-investigator on three research projects that were awarded funding this

fall:

- The *Stress Ulcer Prophylaxis in the Critically Ill: REVISE Renewal Grant*, is a two-year \$1.87M extension by the [Canadian Institutes of Health Research](#) (CIHR) of an extensive multi-centre research project led by McMaster's [Deborah Cook](#) and others. CHEPA's [Feng Xie](#) is also a co-investigator with the project.
- Vanstone is also a co-investigator on the year-long study "*Virtual primary care policy for pandemic preparedness and the new normal: Co-designing resilience, sustainability, quality, equity,*" which received \$100,000 from CIHR.
- McMaster's [MacPherson Institute](#) gave \$25,000 for the one-year project "*Creating community and belonging in inquiry-based educational settings,*" which includes Vanstone among its researchers.

Appointments

He was also appointed to the [Canadian Agency for Drugs and Technologies in Health \(CADTH\) Post Marketing Drug Evaluation](#) (PMDE) advisory committee. The CADTH PMDE program was launched on September 1, 2022, to provide “evidence-based responses to questions and concerns raised by federal, provincial, and territorial decision-makers about drugs approved for use in Canada.” Prior to joining the CADTH PMDE program, Tarride was a core member (health economist) of CADTH’s Health Technology Expert Review Panel (HTERP) from 2017-2022.

CHEPA External Review

An external review of **CHEPA** was conducted in mid-November 2022 to gather information and feedback to help guide the centre going forward.

The review was conducted by [Kim McGrail](#), UBC Centre for Health Services and Policy Research; [Bruce Newbold](#), Director of McMaster’s School of Earth, Environment & Society (EES), and [Mark Stabile](#), Stone Chaired Professor of Wealth Inequality and Professor of Economics at INSEAD, and involved interviews with staff and faculty.
